1. GENERAL EXPLANATIONS

Through this Data Owner Application Form you can use the rights granted to you in accordance with Article 11 of the Law No. 6698 on Personal Data Protection (the “Law”), and you have the following rights regarding your personal data in accordance with the Law.

- The right to ascertain whether your personal data is being processed or not,
- The right to request information regarding the processing of your personal data,
- The right to learn the purpose of processing your personal data and whether they are used for that purpose,
- The right to know the third parties whether within the country or abroad to whom your personal data is transferred,
- The right to request rectification of your personal data if it is incomplete or inaccurately processed,
- The right to request the erasure or destruction of your personal data even if it has been processed in compliance with the law and relevant regulations, once the reasons necessitating its processing have ceased, and to request that any such action taken within the scope of this request be communicated to third parties to whom the personal data has been disclosed,
- The right to object to decisions made against you based exclusively on the analysis of processed data through automated systems, and
- The right to demand compensation for damages in the event of suffering damage due to the unlawful processing of your personal data.

Your request containing the necessary information that will allow you to identify yourself in order to exercise your rights stated above and your explanations regarding your right to exercise the rights specified in Article 11 of the Law; by filling out the Data Owner Application Form at www.tusas.com/yasal/kvkk, via sending a registered letter with return receipt requested to “*Fethiye Mahallesi, Havacılık Bulvarı, No: 17, 06980, Kahramankazan, Ankara, Türkiye*” or via sending an e-mail to the address of tusas.tebligat@tusas.hs03.kep.tr with a secure electronic signature or other methods specified in the Law. Your applications submitted in the specified procedure will be answered within 30 (thirty) days from the date your request reaches us, depending on the nature of the request, in accordance with the second paragraph of Article 13 of the Law. Your answers will be delivered to you in writing or electronically in accordance with the Article 13 of the Law.
